**A RESOLUTION HONORING AND RECOGNIZING THE SERVICE OF

WHEREAS, in recognition of his hard work and dedication to the core principles of the Fund, the members of the TRICO JIF unanimously voted **William J. Bittner, Jr.** as an Alternate Executive Committee member in 2013 and 2014 and as an Executive Committee member in 2015, 2016, and 2017; and

Bittner, Jr.**, for his approach to decision-making; his careful attention to and his assistance in promulgating Fund policies and procedures; his determination to ensure that the Fund would operate in a consistent, orderly and fair manner; and above all, his unwavering dedication to achieving the ultimate goals of the Fund.
