HONORING HARRY RINK

WHEREAS, the Gloucester, Salem, Cumberland Counties Municipal Joint Insurance Fund has been organized pursuant to N.J.S.A. 40A:10-36 et seq., and

WHEREAS, the Commissioners of the Gloucester, Salem, Cumberland Counties Municipal Joint Insurance Fund find it appropriate to recognize a Fund Commissioner of the Gloucester, Salem, Cumberland Counties Municipal Joint Insurance Fund, and

WHEREAS, the Township of Greenwich has been a member of the Gloucester, Salem, Cumberland Counties Municipal Joint Insurance Fund since its inception in 1991; and

WHEREAS, Harry Rink has served as the Township of Greenwich's Fund Commissioner for 25 of the past 27 years, and in his capacity as aforesaid, has been a distinguished Commissioner of the Gloucester, Salem, Cumberland Counties Municipal Joint Insurance Fund, and the Fund is desirous of celebrating his tenure as Fund Commissioner; and

WHEREAS, Harry Rink has been appointed to and dutifully served on Committees of the Fund including the Strategic Planning, where he served for 13 years; Finance, where he served for 12 years, and the New Member Review Committee, where he served as Committee Chair from 1996 through 1998 where he oversaw the application and entrance of several members into the Fund; and

WHEREAS, the Gloucester, Salem, Cumberland Counties Municipal Joint Insurance Fund wishes to recognize Harry Rink, for his approach to decision-making; his careful attention to and his assistance in promulgating Fund policies and procedures; his determination to ensure that the Fund would operate in a consistent, orderly, and fair manner; and above all his unwavering dedication to achieving the ultimate goals of the Fund.
