## RESOLUTION AUTHORIZING THE RELEASE OF FUND YEAR 2019 CLOSED SESSION EXECUTIVE CLAIMS COMMITTEE MEETING MINUTES AS RECOMMENDED BY THE FUND SOLICITOR

WHEREAS, the Gloucester, Salem, Cumberland Counties Municipal Joint Insurance Fund has been organized pursuant to N.J.S.A. 40A:10-36 et. seq.; and

WHEREAS, the Gloucester, Salem, Cumberland Counties Municipal Joint Insurance Fund is duly constituted as a Municipal Self Insurance Fund to provide insurance coverage to its member municipalities; and

WHEREAS, the Gloucester, Salem, Cumberland Counties Municipal Joint Insurance Fund is subject to the provisions of NJSA 10:4-6 the "Open Public Meetings Act"; and

WHEREAS, in 2019 the Executive Committee, during Executive Claims Committee scheduled meetings of the Fund, deemed it necessary to enter into a closed session to discuss matters affecting the safety and property of the public and to discuss pending or anticipated litigation and/or contract negotiations as authorized by NJSA10:4-12; and

WHEREAS, in accordance with NJSA10:4-14 minutes of these closed sessions were transcribed by the Fund Recording Secretary and approved by the Executive Committee; and

WHEREAS, in correspondence dated February 19, 2020, the Fund Recording Secretary requested that the Fund Solicitor review the closed session meeting minutes from Fund Year 2018 to make a determination as to whether any of these minutes could be released to the public; and

WHEREAS, in correspondence dated April 6, 2020, the Fund Solicitor advised the Executive Director's Office that the Closed Session Minutes from the 2019 Executive Claims Committee Meetings can be released with certain redactions.

**NOW THEREFORE BE IT RESOLVED,** by the Commissioners of the Gloucester, Salem Cumberland Counties Municipal Joint Insurance Fund that the Closed Session Minutes from the 2019 Executive Claims Committee Meetings can be released to the public in their entirety, except for the following specific sections of these minutes, as the matters discussed are still unresolved:

- 1. In the February 25, 2019 minutes, the discussion on page 2 regarding the Workers' Compensation claims involving twenty-six (26) Police Officers who were sent to the ER for evaluation after a hostage incident should be redacted.
- 2. In the June 24, 2019 minutes, Mr. Miola's discussion on page 2 concerning the JIF's collection efforts against Mr. Killen, the former JIF Solicitor, should be redacted.
- 3. In the October 28, 2019 minutes, Fund Cahir Law and Mr. DeWeese's discussion on page 2 concerning the City of Vineland's continuing Police Officer/Police Chief issues should be redacted.
- 4. In the October 28, 2019 minutes, Mr. DeWeese's discussion on page 3 detailing a pending Monroe Township Police Department/Civil Rights matter in the United State District Court should be redacted.

**BE IT FURTHER RESOLVED** that a copy of this Resolution by forwarded to the Fund Recording Secretary and Executive Director for their knowledge and action as required.
