**WHEREAS**, the TRICO JIF wishes to recognize Carl Bagby, for his approach to decision-making; his careful attention to and his assistance in promulgating Fund policies and procedures; his determination to ensure that the Fund would operate in a consistent, orderly and fair manner; and above all, his unwavering dedication to achieving the ultimate goals of the Fund; and

**WHEREAS**, the Fund recognizes that while Carl may be retiring from Swedesboro, there are still many fish in his future waiting to be caught as he enters this new chapter of his life;
