WHEREAS, the Commissioners of the TRICOJIF find it appropriate to recognize the service to the Fund of a Fund Commissioner of the Gloucester, Salem, Cumberland Counties Municipal Joint Insurance Fund; and

WHEREAS, Maureen Abdill, the Fund Commissioner from the Township of Pilesgrove, and in her capacity as aforesaid, has served as a dedicated and distinguished Commissioner of the TRICO JIF, and the Fund is desirous of recognizing her tenure as a Fund Commissioner; and

WHEREAS, in recognition of her work and dedication to the core principles of the Fund, the members of the TRICO JIF unanimously voted Maureen Abdill as an Executive Committee Member beginning in 2007 and culminating with her election as Fund Secretary in 2013; and

WHEREAS, the TRICO JIF wishes to recognize Maureen Abdill, for her approach to decision-making; her careful attention to and her assistance in promulgating Fund policies and procedures; her determination to ensure that the Fund would operate in a consistent, orderly and fair manner; and above all, her unwavering dedication to achieving the ultimate goals of the Fund; and

WHEREAS, the Fund recognizes that while Maureen may be retiring from Pilesgrove Township, she will have plenty of exciting adventures ahead of her as enters this new chapter of her life;
