A RESOLUTION HONORING AND RECOGNIZING THE SERVICE OF PAUL J. MIOLA, CPCU, ARM TO THE GLOUCESTER, SALEM, CUMBERLAND COUNTIES MUNICIPAL JOINT INSURANCE FUND

Miola has been involved, he should be most proud knowing that the risk management and safety programs he has created and successfully implemented over the years has led to fewer employee injuries and a safer environment for residents of member towns; and

WHEREAS, Paul J. Miola will always be remembered for his insight into complicated matters, his problem solving capabilities, his ability to identify new exposures impacting the JIFs, his ability to bring out the best in the JIF Professionals with which he worked so closely, and his ability to bring levity to tense situations with his famous one liners and endless supply of jokes; and

WHEREAS, the Fund Commissioners of the TRICO JIF wish to extend to Paul J. Miola their collective thanks for his dedication, hard work, and personal sacrifices made on behalf of the TRICO JIF.
