**A RESOLUTION HONORING AND RECOGNIZING THE SERVICE OF ROBERT “BOB” LAW
TO THE GLOUCESTER, SALEM, CUMBERLAND COUNTIES
MUNICIPAL JOINT INSURANCE FUND**

WHEREAS, the Gloucester, Salem, Cumberland Counties Municipal Joint Insurance Fund (hereinafter “TRICO JIF”) is duly constituted as a Municipal Joint Insurance Fund pursuant to N.J.S.A. 40A:10-36 et seq.; and

WHEREAS, the Commissioners of the TRICO JIF find it appropriate to recognize the service to the Fund of a Fund Commissioner of the Gloucester, Salem, Cumberland Counties Municipal Joint Insurance Fund; and

WHEREAS, Robert Law, Fund Commissioner for the City of Woodbury, and in his capacity as aforesaid, has served as a dedicated and distinguished Commissioner of the TRICO JIF, and the Fund is desirous of recognizing his tenure as a Fund Commissioner; and

WHEREAS, Robert Law, represented the City of Woodbury as Alternate Fund Commissioner beginning in 2002 before being appointed as Fund Commissioner in 2011; and

WHEREAS, during his tenure with the Fund, **Robert Law** has actively served as a member of the Employment Practices & Cyber Liability Committee and the Finance Committee where he served as Chair of the Committee from 2013 through 2016; and

WHEREAS, in recognition of his hard work and dedication to the core principles of the Fund, the members of the TRICO JIF unanimously voted **Robert Law** as Secretary of the Fund in 2017 and 2018 and as Chair of the Fund in 2019 and 2020; and

WHEREAS, in 2014 when the Fund was in need of a liaison to represent the Fund’s interests at the New Jersey Municipal Excess Liability Joint Insurance Fund, the Residual Claims Joint Insurance Fund, and the Environmental Risk Management Joint Insurance Fund, **Robert Law** volunteered to serve in this capacity; and

WHEREAS, the TRICO JIF wishes to recognize **Robert Law**, for his approach to decision-making; his careful attention to and his assistance in promulgating Fund policies and procedures; his determination to ensure that the Fund would operate in a consistent, orderly and fair manner; and above all, his unwavering dedication to achieving the ultimate goals of the Fund.


