**A RESOLUTION HONORING AND RECOGNIZING THE SERVICE OF LEO SELB TO THE

WHEREAS, the Gloucester, Salem, Cumberland Counties Municipal Joint Insurance Fund (hereinafter “TRICO JIF”) is duly constituted as a Municipal Joint Insurance Fund pursuant to N.J.S.A. 40A:10-36 et seq.; and

WHEREAS, the Commissioners of the TRICO JIF find it appropriate to recognize the service to the Fund of a Fund Commissioner of the Gloucester, Salem, Cumberland Counties Municipal Joint Insurance Fund; and

WHEREAS, **Leo Selb**, Fund Commissioner for the Township of Hopewell, and in his capacity as aforesaid, has served as a dedicated and distinguished Commissioner of the TRICO JIF, and the Fund is desirous of recognizing his tenure as a Fund Commissioner; and

WHEREAS, **Leo Selb**, drawing upon his experience working with Joint Insurance Funds for many years, and recognizing the value of membership in the TRICO JIF to the Township of Hopewell, worked diligently to bring Hopewell Township into the JIF in 2020; and

WHEREAS, before joining Hopewell Township, **Leo Selb** served as a Fund Commissioner in the Burlington County Municipal Joint Insurance Fund representing the Township of Hainesport; and

WHEREAS, during his many years as a public servant, **Leo Selb**, has worked closely with Atlantic, Burlington, & Gloucester Salem Cumberland Counties Joint Insurance Funds as a member of the Police Ad Hoc Committee and worked closely with the NJ State Chiefs of Police where he was instrumental in creating the Police Accreditation Program; and

WHEREAS, after more than 37 years in law enforcement, working as an Administrator in a Fire Department, and as an Administrator and Clerk in municipalities in Southern New Jersey, **Leo Selb** leaves behind a legacy on which he can be proud and has earned the right to spend more time with his family; and

WHEREAS, the TRICO JIF wishes to recognize **Leo Selb**, for his approach to decision-making; his careful attention to and his assistance in promulgating Fund policies and procedures; his determination to ensure that the Fund would operate in a consistent, orderly and fair manner; and above all, his unwavering dedication to achieving the ultimate goals of the Fund.

NOW, THEREFORE, BE IT PROCLAIMED, by the Commissioners of the Gloucester, Salem, Cumberland Counties Municipal Joint Insurance Fund assembled in a public session on May 22, 2023, that this body does hereby honor and congratulate **Leo Selb** for his many years of unselfish and dedicated service; and

BE IT FURTHER RESOLVED, that copies of this Resolution shall be provided to the Mayor and Committee of the Township of Hopewell for their information and attention.


